TERMS AND CONDITIONS FOR RUNNERS SEEKING GUARANTEED ENTRY

FUNDRAISING COMMITMENT: A \$2,500 minimum donation is required to join the RISF Team and obtain a guaranteed entry into the ING New York City Marathon 2011 (the "Marathon"). You understand that you are responsible for raising no less than \$2,500 and that if the fundraising minimum has not been reached by one week prior to the Marathon (10/30/11) that you are responsible to pay *in full* the remaining funds owed to reach the fundraising minimum commitment to participate in the Marathon. You are responsible for raising \$2,500, even if for any reason, including injury, you are unable to run in the Marathon. Donations received by shall not be refunded. If you are accepted onto the RISF Team, \$100 will be charged to your credit card and will be applied towards your fundraising minimum. Your deposit reserves a Marathon entry in your name. Please note that the \$2,500 fundraising minimum is set by the New York Road Runner (NYRR).

MATCHING GIFT POLICY: Many companies match employees' charitable contributions. You can check with your employer to see if your company has this program, and ask your donors if their employers match gifts. Many companies issue matching gift checks quarterly or semi-annually, therefore, it is your responsibility to contact the matching company to ensure the check will be issued before October 30, 2011. If the company's match cycle is past October 30, 2011, the donation may not count towards your minimum commitment.

MARATHON REGISTRATION: Once your RISF Team application is process and approved RISF shall contact NYRR to secure your guaranteed entry. NYRR will then contact you and inform you of the details of how to receive your official race number. NYRR charges a separate processing and entry fee that you are responsible for paying to NYRR directly. *These fees do not count towards your fundraising commitment.*

TERMINATION: You may terminate this agreement with, or without cause, at any time by sending written notice to Deborah Maher. However, your commitment to raise the \$2,500 fundraising minimum shall still applied. Upon your termination, RISF may bill your credit card for the balance owed.

RELEASE AND WAIVER: In consideration of my accepting this entry, I hereby for myself, my heirs, executors and administrators, waive and release any and all rights and claims for damages I may have against RISF and sponsors for any and all injuries suffered by me in the Marathon. TERMS AND CONDITIONS FOR RUNNERS WITH NYRR ENTRY

FUNDRAISING COMMITMENT: A \$750 minimum donation is required to join the RISF Team. This will entitle you to all benefits of team membership except a guaranteed entry into the ING New York City Marathon 2011 (the "Marathon"). You understand that you are responsible for raising no less than \$750 and that if that fundraising minimum has not been reached by one week prior to the Marathon (10/30/11) that you are responsible to pay in full the remaining funds owed to reach the fundraising minimum commitment to participate in the Marathon. You are responsible for raising the \$750 minimum, even if for any reason, including injury, you are unable to run in the Marathon. Donations received by shall not be refunded. If you are accepted onto the RISF Team, \$100 will be charged to your credit card and will be applied towards your fundraising minimum.

MATCHING GIFT POLICY: Many companies match employees' charitable contributions. You can check with your employer to see if your company has this program, and ask your donors if their employers match gifts.
