KEY PROJECTS IN 2023 INCLUDE PRESERVING AND RESTORING THE WATERFRONT AND THE NATURAL REGIONS, IMPROVING 250+ FEET OF PATHWAYS, AND INCREASING THE TREE CANOPY ON THE ISLAND. AS A PUBLIC-PRIVATE PARTNER OF THE CITY OF NEW YORK, RIPA COLLABORATED WITH THE CITY TO PLAN AND EXECUTE THE DEVELOPMENT AND IMPROVEMENT OF THE PARK.
