RIPA MAINTAINED AND IMPROVED 330 ACRES OF NYC PUBLIC PARKLAND ON RANDALL'S ISLAND, WITH A FOCUS ON THE OPERATION AND UPKEEP OF OVER 60 ATHLETIC FIELDS - ONE OF THE MOST HEAVILY USED SPORTS FIELD COMPLEXES IN NEW YORK CITY. RIPA ALSO MAINTAINED AND PROGRAMMED ICAHN STADIUM FOR TRACK AND FIELD EVENTS, INCLUDING THE UPKEEP OF A NEW, PROFESSIONAL SOCCER PITCH.
